#### 關於申請程序

#### **About Application Procedures**

- 問一 我想同時申請多過一個職位,是否需要分數次遞交網上申請?
- Q1 I would like to apply for more than one post. Do I need to make multiple on-line applications?
- 答一不需要。申請人不論申請一個或多過一個職位,都**只需遞交一次網上申請**,但申請人須清晰地輸入所申請的職位。
- A1 No. Regardless of the number of posts applied for, applicants will <u>only have to make one</u> <u>on-line application</u>. However, they should indicate clearly in their application the post(s) they are applying for.
- 問二 除遞交網上申請外,我是否需要向有關招聘職系遞交已填妥的申請書?
- Q2 Do I need to send a completed application form to the recruiting grade(s) in addition to making application through the on-line application system?
- 答二 不需要。申請人只需遞交一份申請(網上申請或郵寄)。申請人可透過互聯網上公務員事務局網頁(www.csb.gov.hk)的網上申請系統遞交申請或將已填妥的申請書 CSB 606 及 CSB 606A 郵寄到香港添馬添美道 2 號政府總部西翼 7 樓 722 室公務員事務局。在截止申請日期後遞交,或未完成的申請書將不獲處理。此外,在臨近截止申請日期,網上申請系統可能需要處理大量申請而非常繁忙,以致申請人有機會未能於截止申請時間前成功完成網上申請程序。故此,申請人應盡早遞交申請。
- No. Applicants should submit <u>only one application</u> through the on-line application system available on the Civil Service Bureau homepage (<u>www.csb.gov.hk</u>) <u>or</u> by post (i.e. sending the completed application forms CSB 606 and CSB 606A to the Civil Service Bureau at Room 722, 7/F., West Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong). Late or incomplete applications will <u>not</u> be accepted. Besides, towards the deadline for application, the on-line application system would likely be heavily loaded with large volume of applications, and it may render you unable to complete your on-line application in time. As such, you are advised to submit your application as early as possible.

- Q3 Can I submit the application form by fax or by email?
- 答三 不可以。以傳真或電郵方式提交的申請書將不獲處理。

- I submitted an application through the on-line application system. I want to apply for more than one post but had selected only one in my application. Can I apply for the other post(s) now? Should I submit several application(s)? (Also applicable to candidates who would like to amend the post(s) they have applied for)
- 答四 每位申請人只能遞交**一份申請**。

#### 在申請期間 -

申請人可透過網上申請系統修改其已遞交的申請書內容·包括已選擇的職位(增加/減少均可)。

### 在截止申請日期後 -

A4 Each candidate should submit only one application.

#### During the application period -

Applicants can amend any information in their application, including the post(s) they have applied for (both addition and deletion are acceptable), through the on-line application system.

# After the application deadline -

**No** amendment to the post(s) applied for is allowed after the deadline for application, i.e. 6 October 2023 (Friday) at 5:00 p.m. Hong Kong Time. Please refer to **Q&A8** for the deadline of amending personal particulars / information on submitted applications.

Please note that the saved information is only applicable to **this year's** CSB606 On-line Application System.

Please also note that some e-mail service providers may put the acknowledgement e-mail in your "Spam" or "Junk" folder. If you indeed have not received any acknowledgement e-mail within two hours after you have submitted the on-line application, please contact the Civil Service Bureau by e-mail (csbasd@csb.gov.hk) immediately.
